- 1. Application:** please include a photocopy of both sides of your Driver's Licence Public liability Insurance photo and list of goods all new goods must be approved by Market manager Stall **Location:** Booking of space and positioning of stallholders are the responsibility of the Market Manager. Stall holders insurance must resubmit a copy of your Insurance on yearly braces on first market of the year also change of address.
- 2. Stall Size:** We provide a 3X3 meter space the display of goods and operation shall be confined to this space will not encroach other Stall Holders.
- 3. Stall Safety:** Stallholders must ensure all their display equipment, e.g. Tables are securely fixed and do not scratch polished floor .
- 4. Stall Appearance:** All stallholders are requested to maintain their stall in a clean and tidy manner and must take away all unsold items, boxes, paper and
- 5 craft stallholders Cars arrive at 48 Fehon St. Setup at 8.30am sharp;**  
Stallholders unloading car outside hall car must have hazard lights on  
Pedestrians always have priority on footpath car parking not included **stallholder can find a car parking in the area but not round park as we need the it for customers.** The same rules apply when Market is finished stallholders must not be inconvenienced the public.  
risks' taking is not accepted otherwise you will be required to leave  
Market **clean- up @ 2pm 1 hour after without exception. No exit before Market finishes**
- 6. Market Cancellation or Early Finish:** will be decided and advised only by the Market coordinator  
This occurrence would only be in extreme circumstances and is at the discretion of the  
Market Manager. Stall Holders are not permitted to pack up early under any circumstances  
**Dogs:** are only allowed on a leash outside hall.
- 7. Payment:** required in advance to secure stall space \$25 for 3X3 space a  
double \$50 until June 2017 contact for Payment details Options by internet or  
directly into Bank call for A/C details.
- 8 No Refunds:** Booking can be moved only once; notice must be given by Tuesday before Market.  
If you have booked a place and are unable to attend contact Market coordinator ASAP.
- 9 Alcohol:** is not allowed to be consumed within the Market
- 10 Food Registration :only at Farmers Market see application on [www.farmersmarket.net.au](http://www.farmersmarket.net.au)**  
**Items must not be sold under any circumstances** Pets or fish, ANY COUNTERFEIT or COPIED or  
STOLEN or illegal goods, tobacco, firearms, explosives, poisons or pornography, electrical goods cannot  
be sold. Stallholders are responsibility for complying with laws and regulations relating to goods for sale.
- 11 All stallholders are obliged to have Public Liability Insurance covers for \$10,000,000.**
