- 1. Registration Requirements: 2017 Upon application Market Management need copies from your Local City Council Health Department, Food Handling Certificate & Public Liability Certificate also registration required on: When approved a certificate from Streatrading Website confirming Maribyrnong Council approval with SOT available on <a href="https://streatrader.health.vic.gov.au">https://streatrader.health.vic.gov.au</a> on approval email from Streatrading directly to me at <a href="mailto:info@armersmarket.com.au">info@armersmarket.com.au</a>
- **2. a) Insurance:** Public Liability Insurance covers the overall operation of the Market. You will need your own cover for \$10,000,000
  - **b)** The Market Management shall not be liable for any person using these premises for personal injury or loss stock or damage whatsoever arising whether by negligence or otherwise incurred or suffered by that person.
- **3. Payment:** required in advance to secure stall space \$100 for first two Markets then \$65 a month in advance for a 3X3 space with a car Contact Eileen 0412910496 for Payment details options pay Urban Acorn Pty Ltd
- **4. Stall Location:** Booking of space and positioning of stallholders are the responsibility of the Market Manager only and must be on time 7.30am otherwise call.
- **5. Stall Size:** The stall space is defined by the markings of a single car parking space with a 3mX 3m tent in front display of goods and operation shall be confined to this space will not encroach into the aisle/path.
- **6. Stall Set up & Pack and clean up:**, Setup 7.30am, clean-up and exit 1 hour after. (Otherwise by instruction, No entry to Reserve prior to coordinator arrives, no exit before official finish time.
- **7. Stall Appearance:** All stallholders are requested to maintain their stall in a clean and tidy manner must ensure all their must ensure all their display equipment is securely fixed (e.g. with sandbags and/or weights Pegs) and must take home all unsold items, boxes, paper and wrappings.
- 8. Stall Food Safety Council Requirements: Food safety program available, monitor record of high risk food stored at ambient temperature, warm water for hand & utensil washing facilities, ground cover, bin with bags all waste taken away by you so we leave everything as we find it. Stallholders must ensure all their display equipment is clean.
- **9. Stall Holder Access:** Car movement must not enter before coordinator arrives then may enter via Powell St on pathway vehicle must be drive at walking pace with hazard lights on then drive straight into space allotted and reverse back to pathway when leaving only no short cuts no driving at back of stalls on grass, set up 7.30am hour before market opening and 1 hour after market closing.
- 9. Dogs: dogs are allowed in the market only on a leash.
- **10. Payment:** Payment is expected one month in advance to guarantee your space on the day of market for following month. When approved call for bank details.

Refunds: No refunds if stall holders do not show up on the day in line with all other Markets. The Market Management reserves the right to refuse admission to the Market to any person without giving any reason and to eject or cause to be ejected any person and/or his/her goods and chattels without giving any reason. This decision is final and binding. Stallholders are responsible for complying with all laws, rules and regulations relating to the food offered for sale.
