Application:** please include a photocopy of both sides of your Driver's Licence Public liability Insurance photo and list of goods all new goods must be approved by Market manager Stall **Location:** Booking of space and positioning of stallholders are the responsibility of the Market Manager. Stall holders insurance must resubmit a copy of your Insurance for 10 million dollars.
- 2. Stall Size:** Bring your own table a 3 meter space is available space the display of goods and operation shall be confined to this space will not encroach other Stall Holders.
- 3. Stall Safety:** Stallholders must ensure all their display equipment, e.g. Tables are securely fixed and do not scratch polished floor .
- 4. Stall Appearance:** All stallholders are requested to maintain their stall in a clean and tidy manner and must take away all unsold items, boxes and wrapping home.
- 5 craft stallholders Cars arrive at 48 Fehon St. Setup at 8.00am sharp;**  
Stallholders unloading car outside hall car obliged to have hazard lights on  
Pedestrians always have priority on footpath car parking not included.
