### Registration Requirements 2019

Upon application Market Management need copies from your Local City Council Health Department, Food Handling Certificate & Public Liability Certificate for \$20,000,000 2019 food stall check list (attached )also SOT required certificate from Streatrading Website confirming Maribyrnong Council approval w <https://streatrader.health.vic.gov.au> on approval email from Streatrading.

- 1. Insurance:** Public Liability Insurance covers the overall operation of the Market. You will need your own cover of \$20,000,000 The Market Management shall not be liable for any person using these premises for personal injury or loss stock or damage whatsoever arising whether by negligence or otherwise incurred or suffered by that person.
- 2. Payment:** Stall cost first two markets \$110 for a 3X3 space with car then \$65 per month payment to **Urban Acorn Pty** required in advance contact for Payment details. Options by internet or directly into Bank. **A once only ten dollar credit will be given to any stall holder who introduces a new Farmers Market stall holder (only if they book and pay for their first two markets.)**
- 3. Stall Location:** Booking of space and positioning of stallholders are the responsibility of the Market Manager only.
- 4. Stall Size:** The stall space is defined by the markings of a single car parking space with a 3m by 3m tent in front display of goods and operation shall be confined to this space will not encroach into the aisle/path.
- 5. Stall Set up & Pack and clean up:** Setup 1 hour before, clean-up and exit 1 hour after. (Otherwise by instruction, take all waste home with you. No entry to Reserve prior to coordinator arrives, no exit before official finish time.
- 6. Stall Appearance:** All stallholders are requested to maintain their stall in a clean and tidy manner must ensure all their must ensure all their display equipment is securely fixed (e.g. with sandbags and/or weights no Pegs) again stall holders must take away all unsold items, boxes, paper and wrappings.
- 7. Stall Food Safety Council Requirements: have a folder on board at all times with all paperwork for Council Heath Dept. Check list on website** Food safety program available, monitor record of high risk food stored at ambient temperature, warm water for hand & utensil washing facilities, ground cover, bin with bags all waste taken away by you so we leave everything as we find it. Stallholders must ensure all their display equipment is clean.
- 8. Stall Holder Access:** Cars must not enter before coordinator arrives at 730am then may enter via Powell St on pathway, vehicle must be driven at walking pace with hazard lights on then drive straight into space allotted and reverse back to pathway. When leaving no short cuts, no driving at back of stalls on grass, then set up before market opening and clean up 1 hour after market closing please take all waste home. **Dogs: are allowed in the market only on a leash.**
- 9. Cancellation policy.** Stall holders must give one month notice in order to give time to replace your stall for that month. A credit can issued for the next market when one month notice is given, otherwise no credit will be issued. No refunds under any circumstances, we are an all-weather market.
- 10. Payment:** Payment is expected one month in advance to guarantee your space on the day of market for following month. When application approved please call for bank details.  
**The Market Management reserves the right to refuse admission to the Market to any person without giving any reason and to eject or cause to be ejected any person and/or his/her goods and chattels without giving any reason. This decision is final and binding. Stallholders are responsible for complying with all laws, rules and regulations relating to the food offered for sale.**
