Arrival Food at 10.00 St. Mangos Lane Craft 10 .15am via Docklands Drive left on Doppel Way then left to Caravel Lane. Wait in line on left side of road Keeping hotel clear. **No entry before Market Coordinator arrives**, we will place you in order of entry, food stalls St Mangos Lane then placed for entry to Promenade Food stallholder arrive in order enter via St Mangos Lane only when asked then to enter at walking pace with hazard lights on to placement on Promenade by coordinator. **No admittance before Manager arrives** Display of goods and operation shall be confined to a 3X3 meter space car included in price (behind stall) no Power do not encroach on bluestone pedestrian path or other Stall Holders, if your stall position needs to be changed it will be at the discretion of the Market Manager and is final. Barrier as possible, stallholders must not unload on water side to do so is at your own risk. Gazebo to be in line with bluestone walkway leaving 3 meters clear for pedestrians. Trading stops at 7pm Clean-up 1 hour after without exception and take all your rubbish with you. **Bollards are locked to stop unauthorized cars from entry and exit to keep everyone safe. Stalls *Must not exit the Promenade until market finish, you will be given* Please remain in your vehicle until you are authorized to exit. Market Finishes at The bollard must remain locked until authorized personnel from City wide/ Melbourne City Council unlocks it. Anyone trying to remove bollard will be fined by the council for property damage.**

Stall Safety & Appearance: Stallholders must ensure all their display equipment, tents, tables, are **Securely fixed, sandbags 20kg weights per leg. Each car must have a drip tray under the engine in case of oil leaks as required by City of Melbourne,** st Maintain stall in a clean and tidy manner and work within 3X3 space, take home all waste. We advise all stalls have sanitizer available for shopper. Dogs are allowed on a leash

Fees

- 1 Stallholders must pay in advance to secure stall.
- 2 Stallholders when approved we will send payment details indicate date wanted.
- 3 Failure to pay you will be replaced Site being cancelled, which may be allocated to another party.
- 4 Stallholders acknowledge that the Markets are all weather dependent. To the extent permitted by law, we will not issue credits or refunds to Stallholders for any weather events.
- 5 Market fees will not be refunded if a Stallholder does not attend the Market at the scheduled time (whole or partly) First When Paid A Map of Direction entry will be sent to you.

STOLEN or illegal goods, tobacco, firearms, explosives, poisons or pornography, alcohol, electrical goods, CDs cannot be sold. Stallholders are responsible for complying with laws and regulations relating to all goods.

3. Insurance: All stallholders must have current Public Liability Insurance cover for \$10,000,000 for the Market. Have 20 Kilo weights on each leg of tent. The Market Management shall Will **not** be liable for any person using these premises for personal injury or loss of or damage to stock whatsoever whether by negligence or otherwise incurred or suffered by that person. The Market manager has insurance over the market. The Market Management reserves the right to refuse admission to the Market without giving any reason and to eject or cause to be ejected any person goods and chattels. This decision is final and binding. Stallholders are responsible for complying with all laws, rules and regulations relating to goods/food. Please be mindful of noise levels.

4. Disputes. Please refer any complaints to Eileen- market manager 0412 910 496 and do not approach other stall holders in a negative manner. We wish for the market to be a friendly and happy place.

All new products must be approved by the market manager before sold at the market.

5. Emergency procedures: In case of emergency, illness, or accident to public or stallholder. First At First Aid Tent contact Eileen Fiederling, Market Coordinator 0412 910 496; In case of emergency all stallholders must assemble at First Aid Tent on being informed. Leave area when asked in order on instruction taking only money or handbags only, leave stall cars locked. Emergency Entry: via St Mangos Lane must be kept clear or Police Ambulance or Fire Brigade.
