Yarraville Village Page 2 rules Farmers Market 2025

- 1. Upon application or annual renewal Market Management need copies off your Public Liability Certificate 2024/25 for ten million dollars Driver's License, also SOT/Food Council Certification, certificate from Street trading with dates also required Carry Covid Risk Management plan. All food stalls Payment one month in advance to secure and receive your documents your space otherwise we will replace your stall booking only confirmed on receipt of payment.**
- 2. a) Insurance:** Public Liability Insurance covers the overall operation of the Market. You will need your own cover of ten million Dollars required by Council. The Market Management shall not be liable for any person using these premises for personal injury or loss of stock or damage whatsoever arising whether by negligence or otherwise incurred or suffered by that person.
- 3. Stall Location and complaints resolution:** Booking of space and positioning of stallholders are the responsibility of the Market Manager only. Please refer any complaints to Eileen-market manager 0412 910 496 and do not approach other stall holders in a negative manner. We wish for the market to be a friendly and happy place.
Stall Size is 3x3: Please enter at 7.30 AM drive in from Powell St near children's playground, at walking pace with hazard lights on for **Entry/Setup from Powell st. at 8.00am Market finishes at 1pm exit by Blackwood St honk Horn before exit because of House on right At Blackwood St**, no entry prior to co-ordinator manger arrival who will place you. **Dogs are allowed at Council Request. Customers are allowed to have Dogs on a leash No Alcohol to or cigarettes to be consumed by Stall holder. Stall Appearance:** All stallholders are requested to maintain their stall in a clean and tidy manner & must ensure all their display equipment is securely fixed you are there for such a short time it is better you stand to welcome your customer (with sandbags /or weights only) stallholders must take away all unsold items, boxes, paper, wrappings, we leave everything as we find it. **(No Plastic only recycle)**
- 4. Stall Food Safety Council Requirements:** Please **Have a folder on board at all times with your paperwork for council health department (checklist on website)** Food safety program available, monitor records of high-risk food at ambient temperature, have hot water for hand and utensil washing facilities, Fire extinguisher/Fire blanket ground cover, bin with bags for waste to take home so we leave things as we find them Stallholders must ensure all their display equipment is spotlessly clean keeping to Current Council requirements.
- 5. Cancellation Policy.** Stall holders must give one months' notice giving us time to replace you if we can for some reason you feel ill and cannot attend ring us straight away if we can replace you, we will give you a credit for next Market. Otherwise, no refunds under any circumstances. We are an all-weather market.
- 6. Payment:** The booking is only accepted when paid in advance, payment details given when application approved. **\$75 All ways in advance for each market) The Market Management reserves the right to refuse admission to the Market to any person without giving any reason and to eject or cause to be ejected any person and/or his/her goods and chattels without giving any reason.
