**Application:** please include a photocopy of both sides of your Driver's Licence, Public liability Insurance 10 million, photo, and list of goods. All new goods must be approved by Market manager. Stall Location: Booking of space and positioning of stallholders are the responsibility of the Market Manager. Stall holder submits a copy of your insurance on a yearly basis on first market of the year also change of address.

- 1. Stall Safety:** Stallholders must ensure all their display equipment; tents are securely fixed with weights only. Stall Size: A 3 x 3-meter space allowing space for safe distance, the display of goods and operation shall be confined to this space and should not encroach on other Stall Holders.
- 2. Stall Appearance:** All stallholders are requested to maintain their stall in a clean and tidy manner and must take home all unsold items, boxes, paper etc.
- 3. Stall Holder Dispute/Complaints-** Please refer any complaints to Eileen- market manager 0412 910 496 and do not approach other stall holders in a negative manner. We wish for the market to be a friendly and happy place.
- 4. Craft stallholder's cars arrive at 8am** Drive on Path entry at court St Yarraville. Escorted by Manager drive to spot. Please wait for market manager/marshal to allocate your space. Drive at walking pace with hazard lights on. Pedestrians always have priority, public risk taking is not accepted otherwise you will be required to leave. The same rules apply when exiting when Market finishes. Market starts 9am finish at 1.00 pm Not before clean-up is 1 hour after without exception. No exit before Market finishes.
- 5. Market Cancellation or Early Finish:** will be decided and advised only by the Market coordinator. This occurrence would only be in extreme circumstances and will be advised by Market Management. Stall Holders **are not** permitted to pack up early under any circumstances. Dogs are allowed on lead only.
- 6. Payment-** Always in advance so we can advertise you. See page 1 When your application has been approved, we will send payment details for direct deposit to account, **No Refunds Under Any Circumstance:** Booking can be moved only once; notice must be given a week in advance before Market. If you have booked a place and are unable to attend, contact Market Manager. **Food Registration-**only at Farmers Market see application Alcohol is not allowed to be consumed within the Market. **No smoking of any kind on premises.** **Items that must not be sold at market** Pets or fish, ANY COUNTERFEIT or COPIED or STOLEN or illegal goods, tobacco, firearms, explosives, poisons or pornography, electrical goods cannot be sold. Stallholders are responsible for complying with laws and regulations.
- 7. The Market Management shall not be liable for any person** using these premises for personal injury or loss stock or damage whatsoever arising whether by negligence or otherwise incurred or suffered by that person. **The Market Management reserves the right to refuse admission** to the Market to any person without giving any reason or to eject or cause to be ejected any person plus goods and chattels.
